Dear parents and carers,

Season's greetings. I hope that you and your loved ones are still enjoying a peaceful holiday.

Schools and the pandemic have been discussed much in the press recently and I can confirm the details below following the information shared yesterday afternoon by the Secretary of State for Education.

The situation with schools is constantly being reviewed and so I will be in contact if anything changes.

To be clear, the Christmas holiday <u>has not been extended</u>. From Tuesday 5<sup>th</sup> January all pupils at the school will begin the term either onsite or remotely.

#### Mass testing in schools

On Friday 18<sup>th</sup> December, the Department for Education announced that schools will have access to thousands of lateral flow test kits in order to help identity asymptomatic Covid19 cases in school populations.

As you can imagine, this is a significant piece of work and one which can only work within the constraints of the school's limited capacity.

We have planned a number of stages in order to be able to increase testing for pupils at the school. The first stage involves gaining parental consent. Please read the attached leaflet provided by the Department for Education carefully, next week you will receive a DfE-approved consent form. You will need to state if you will give permission for your child to be tested for Covid19 at school and for their data to be processed.

Your child will be able to continue to attend school if you do not give consent to testing, as long as they are not displaying any recognised symptoms of Covid19.

At present, no testing will be taking place for pupils and staff as consent has not been sought and the training guidance has not yet been released by the Department of Education.

#### **Remote learning**

Before the Christmas break you were invited to comment on the school's remote learning offer. Many thanks to all of you who shared your thoughts. We also surveyed pupils again and the results will be shared with you as soon as we can. We continue to try to make our remote learning offer as inclusive and effective as possible. The vast majority of teaching staff will be delivering remote learning from the school site from Tuesday 5<sup>th</sup> January. Please continue to get in contact with the school with your views.

There will be a number of updates from the school and local authority over the next few days. Please be assured that we are doing all we can to ensure that any disruption to the education and positive school experience of our pupils is limited.
